




Discounts by PI – Tranche 1




Discounts by PI – Tranche 2




Tranche 1 transfer – Loan Balances




Tranche 2 transfer – Loan Balances




Proportion transferred in Tranche 1




Proportion transferred in Tranche 2




Proportion transferred in Tranche 1 + 2




Tranche 1 - Geographical breakdown




Tranche 2 - Geographical breakdown
