Independent Investigation of Syria Chemical Attack Videos and Child Abductions

EXECUTIVE SUMMARY

ISTEAMS is a team of interdenominational religious and lay observers from communities and spiritual centers in and outside of Syria, as well journalists. At considerable risk in the present terrorist insurgency, ISTEAMS independently investigated the chemical weapons attack in the town of East Ghouta on August 21, 2013, as well as the video media purporting to document these events. This report is being produced for the International Institute for Peace, Justice and Human Rights (www.ipj.ch) for dissemination to the international community.

The findings and evidence of ISTEAMS' initial report strongly refute the claims by US-UK-Saudi-Turkish-Israeli and other Western interventionists. These claims are largely based on video evidence of this mass murder produced by Syrian insurgents and terrorists. For this reason, a rush translation of ISTEAMS' working document on the Ghouta massacre and related atrocities and child abductions in Latakia, Syria, has been produced to inform international public opinion and do justice to the innocent victims of these crimes. The draft report <u>includes a Name List of abducted children and women (pp. 45-50) who may have been massacred by the Syrian insurgents who perpetrated the Ghouta outrage.</u>

Finding: Ghouta Chemical Weapons Massacre Videos Preceded the Attack (pp. 4-5)

The 13 videos purporting to show the events in East Ghouta during the early morning of August 21 were complete and were uploaded to the YouTube social media site in California, USA, <u>in advance of the earliest reports of the attack.</u> Logs of activity on YouTube as well as downloads of the material by ISTEAMS members show that the videos were produced before the claimed chemical massacre.

Finding: Ghouta Is a Ghost Town, the Population All Fled the Rebels (pp. 8-11)

East Ghouta is a distant eastern suburb (exurb) of Damascus that was until recently a farming community. The urban population came mostly from Damascus and fled there as refugees to family members when rebels seized the town. Ghouta is no longer a community that includes women and children, but rather an armed camp of militant men, including many violent zealots. The social picture represented in insurgent videos is at complete variance with the demographic facts and street scenes of Ghouta under occupation – there are no women or children to be seen at all. Also, insurgent medical responders appearing in videos revealed that large numbers of children casualties were sleeping dormitory-style in a few facilities, where they were all killed by gas in the early hours of August 21st (page 11). Even though the children were assembled together in Ghouta, their names are never given.

Finding: Major Medical Discrepancies in Videos (pp. 12-13)

Medical personnel presented in the videos and subquent news presentations by al-Jazeera differ starkly in their factual accounts of events, the availability of medication and its efficacy in the situation, and their personal safety while working with chemical weapons victims and environments.

Finding: No Women; Children Shown Sleeping on Floors in Street Clothes (pp. 14-17)

Videos depicting the casualties show large numbers of children supposedly sleeping on floors and wearing day clothes. Families shown together also wear day clothes.

Finding: Staged and Fake Images (pp. 19-35)

A sensational photograph claimed as proof of the attack actually shows casualties from an Egyptian riot. Other images are obviously staged and many use victims as props. Still others appear to show children dead, and then subsequently alive. This is unlawful propaganda of the most cynical and ghoulish kind.

Finding: Victims May Be Abducted Women and Children from Latakia (pp. 36-43)

Possibly most disturbing, the findings of this initial report establish multiple connections between the Ghouta massacre and a series of terrorist massacres and wholesale abductions in several towns in western Syria during several days in early August 2013. These massacres occurred in the region surrounding the seaport of Latikia.

CONCLUSION

Ghouta Child Victims Were Abducted by Terrorists from Latakia (Name list, pp. 45-50)

After insurgents murdered the men in these communities, they organized mass abductions of the surviving women and children. ISTEAMS' report includes evidence that links these abductions to the ensuing chemical attack(s) that killed mainly women, children, and infants in Ghouta, east of Damascus, on August 21, 2013. Women and children who went disappeared after their families were massacred in Latakia appear to be among the Ghouta victims shown in western propaganda videos.

This preliminary report was prepared by ISTEAMS investigators and observers of all faiths working inside and outside the Syrian Arab Republic, as well as independent European and Australian journalists supporting Syrian sectarian and secular reconciliation (al-Mussalaha).

FOREWORD

This is a modest study on some of the 13 videos nominated by the US Intelligence Community and similar documentation.

Since the moment where some families of abducted children contacted us to inform us that they recognized their children among those who are presented in the videos as victims of the Chemical Attacks in East Ghouta, we decided to examine the videos thoroughly. We have restricted ourselves from treating medical or geospatial issues because it needs experts. Our work was limited to our simple observation of the videos from a sociological and a scenographical point of view.

We found that, as a whole, the videos present a clear absence of a normal Syrian family life, with no signs of the presence of a resident civilian population. While the proliferation of young males and children everywhere, dead or alive, let us wonder who they are and what they are doing in East Ghouta without their families?

Our first concern was the fate of the children we see in the footages. Those angels are always alone in the hands of adult males that seem to be elements of armed gangs. The children that trespassed remain without their families and unidentified all the way until they are wrapped in the white shrouds of the burial. Moreover, our study highlight without any doubt that their little bodies were manipulated and disposed with theatrical arrangements to figure in the screening.

Thus we accuse the editors of the videos of artificial scenic treatment of what should have been honest information footage. The cynic manipulation of the little inanimate bodies, that seem to be under anesthesia, endangered the life of the children and raises in our minds the question of their safety and the real reason of their death.

If the studied footages were edited and published to exhibit pieces of evidence to accuse the Syrian State of perpetrating the Chemical Attacks on East Ghouta, our discoveries incriminate the editors and the actors of forging facts through a lethal manipulation of unidentified children. Thus we want to raise International Awareness toward the humanitarian case of this criminal use of children in the political propaganda of the East Ghouta's Chemical Attack.

We present this work to distinguished Spiritual Leaders, Head of States, Head of Delegations, Senators, Members of Parliament, Humanitarian actors and to any person that has a heart for truth and justice and that seeks the due accountability for evil deeds •

INTRODUCTION

The USA and allies said that they relate to videos shown on thursday 5th of September 2013 to members of the Senate Intelligence Committee, presented by the Intelligence Committee as verified and authentified by the Intelligence Community to incriminate the Syrian State for the illegal use of Chemical arms in East Ghouta.



The videos selected and let us say "nominated" are 13 videos that are amongst the first 35 to have been uploaded by the different video makers of the Local Coordination Committees of the rebels in the East Ghouta¹.

You can see them 2 downloaded by Felim Mac Mahon. All of them are in the first seven hours of the 21st of August (still 20th of August California time). All but the N°8 were uploaded 2 to 7 hours after the alleged first impact of the chemical weapons.

Here is the list, we inserted the US Nominated Videos in the Chronology of the Events.





Alleged CW Attacks - Chronology

Human Rights Watch report

Activists reported chemical weapons (CW) attacks from around 0230 local time on August 21 in East Ghouta, Damascus. Only a man who alleged to be a rescuer from Zamalka affirms that the attacks begun at 0155 local time.

Initial reports made reference to three adjoining locations: Jobar, Ein Tarma, and Zamalka. However, we believe that the sole location hit may have been around Zaynia in Ein Tarma, a built-up area that borders Zamalka.

Victims of the alleged attack were reportedly treat-

ed at the following locations: Jobar, Kafr Batna, Hamoryah, Irbin, and Douma. These are marked with red bullets on the maps. All of the content featured by Storyful comes from uploaders associated with the areas affected, and the areas were victims where treated.

The attacks came amid fighting in the area, with local activists reporting the downing of a chopper, that was false and the taking of a telecommunications building, in Jobar, in the hours before the attack. All times quoted here are local Syrian times.

Reports from Jobar:

At 0235, the first report of a chemical weapons attack was posted by the Jobar Revolutionary Coordination Committee here. It gave the location of the 'chemical shell' strike as Zaynia, Ein Tarma.

At 0323, a posting on the same account said chemical weapons had been used on Jobar and Ein Tarma. This was repeated here a few minutes later.

A posting at 0340 reported that hospitals were crowded with women, children and the elderly.

At 0433, the first video was posted, said to show a boy from Ein Tarma affected by chemical weapons. The uploading YouTube account was from Jobar.

At 0539, Jobar Revolutionary Coordination Committee indicated 600 wounded "in Jobar, Ein Tarma and Zaynia". A posting at 0601 claimed that 15 chemical shells were used in the alleged attack with sarin gas. It stated that around 0300 the people died while sleeping and that the quantities available of atropine and oxygen were coming to an end.

At 6:05 am, Reuters was able to diffuse the news with solid documentation about already 200 people killed. Look at the photo. It is said to be provided by the Sham News Network.

Reports from Ein Tarma:

At 0245, Ein Tarma Coordinating Committee reported that several people in Zaynia were suffering from suffocation as a result of the town being "bombed with toxic substances". Zaynia is a high-density housing area on the border of Ein Tarma and Zamalka.

A posting at 0313 gave the location of the in-

cident as "between Ein Tarma and Zamalka". At 0315, it was reported that the cause of this was a ground-to-ground chemical rocket that exploded in the area. Again, the area was given as "between Ein Tarma and Zamalka".

At 0355, the same source reported dozens of dead among them children, women and elders at several field hospitals. With a sharp lacking of oxygen.

At 0402, the page posted images fonted with a logo belonging to media activists in nearby Erbin, tagged as showing victims from Ein Tarma. Shortly afterwards, it posted videos from Erbin tagged as showing Ein Tarma's dead and wounded.

Some postings on general postings the page listed the affected areas as Jobar, Zamalka, and Ein Tarma. For instance here.

At 0427, Ein Tarma Coordinating Committee warned of a toxic cloud spreading from Zaynia, and started posting the first videos from nearby Kafr Batna's coordinating committee. Kafr Batna was one of the areas the wounded were brought.

Reports from Zamalka:

At 0226, the Zamalka Revolutionary Coordinating Committee reported the bombing of 'the city' with 'toxic substances', but did not give any further geographical information. But the first reader below opposes this allegation saying that the chemical attacks are clearly on Aïn Tarma and that the missiles passed over their heads in Zamalka and that this allegation have dropped the attention to Zamalka and weakened the attendance to Ain Tarma, provoking a supplement of casualties.

At 0245, the same source reported 20 cases of 'suffocation and fainting' here. In general, the reports from Zamalka Revolutionary Coordinating Committee refer only to Jobar and Ein Tarma as the affected locations, for instance here.

Conclusion: The only specific location mentioned by these three accounts is Zaynia, between Ein Tarma and Zamalka, which is also close to Jobar. Given the lack of precise location information from either the Jobar or Zamalka coordinating committee pages, we believe that it is possible that the attack was centred on Zaynia. In the case of an attack as described, using rockets, and centred on Zaynia, some projectiles may well have fallen on Zamalka, or even on the outskirts of Jobar. Victims sought medical attention at several locations. Casualty videos came in volume from Irbin and Douma.

A video of a rocket purportedly used in the attack has been geolocated to a spot around 200m from Zaynia by Eliot Higgins here. Having reviewed the work, we don't have any doubt that it has been correctly geolocated. An activist produced map, which we have not validated, indicates that several rockets fell in this area, along a line spanning 1km.

Moadimiyah Al Sham: Separate Attack? There were reports of heavy shelling and a separate CW attack on Moadimiyah Al Sham, which lies to the south-west of the capital. Initial reports and videos indicated a smaller-scale event, with the reported death toll attributed to CW jumping from 7 to 56 late on August 21.

0536 — Reports dozens killed by CW rockets 'in the city'. Most of the casualties are children and women. Location not specified here.

1144 – Continued shelling reported, but no mention of CW here.

1757 — Names martyrs from Moadamiyeh killed in "chemical massacre of August 21". No location for strike given here.
Several subsequent posts updated on CW casualty figures from the "chemical massacre of August 21". None mentioned location beyond saying 'the city'. However, a YouTube channel from Moadamiyeh posted videos of victims here, here, and here. The videos did not show the kind of mass-casualty incidents portrayed in videos from East Ghouta.

1813 – Report puts death toll from CW at seven

2051 — Report here named 52 casualties from Moadamiyeh killed on August 21. It is unclear from the report how many were being claimed as CW deaths.

2203 – Report here clearly links the 56 deaths listed to the use of CW.

SOME PRELIMINARY OBSERVATIONS ABOUT THE URBAN AND SOCIAL ENVIRONMENT OF EAST GHOUTA

EAST GHOUTA IS A PART OF THE RURAL DAMASCUS.

The Damascus Ghouta is a green agricultural belt surrounding the City of Damascus in the South and East. Separating the city from the dry grasslands bordering the Syrian Desert, it has provided its inhabitants with a variety of cereals, vegetables, and fruits for thousands of years. While human settlements in the area date back to ancient times, an uncontrolled development of the area took place throughout the past decades. The increasing food demand by the rapidly growing population of the capital, urbanization and industrial development have increased the pressure on the agricultural lands (Wikipedia).

The explanation of the social situation of Damascus Ghouta since 2011 by Mr. Mahmoud Abdel Salam, the manager of several educational institutes in Ghouta: Since the beginning of the crisis many families decided to leave Ghouta. They were in reality "urbanely displaced" since the prices of

the real estate in central Damascus jumped a lot of the Damascene middle class decided to sell their houses and buy a much cheaper property in Ghouta. Even if Ghouta is at the doors of Damascus, it formed a rural area whose habitants were farmers. In less than three decades the population increased by ten. Those who came from Damascus had still family and parents. It was easy for the majority of the population to move out. Today Ghouta is empty. Only the families of the opposition fighters and some original habitants who did not find where to go are still there.

PERSONAL TESTIMONY

- I was in Damascus two days before. There was the heaviest shelling from the Syrian legal army on the East Ghouta. Going out to Lebanon I have seen thousands of refugees fleeing the targeted areas.
- It means that the area that was already emptied from its population was more emptied during the heavy attack of the Syrian army.
- Hear the little orphan who was interviewed having allegedly lost his parents: "who else died among your friends and neighbors? He said nobody they had already left or are refugees





This boy, Abdullah, does not say where he lives in the East Goutha. He asserts what everybody in Damascus and its rural area knows: that most of the neighbors had already fled from their houses because the East Ghouta is a semi destroyed area due to the continuous clashes between the rebels and the syrian army and the violent aerial strikes and shellings from the Syria army. - The number of casualties as reported by the United Medical Office of East Ghouta is in direct contrast with the present density of the population in a devastated urban scene.

First report from the medical office of Jobar neighborhood concerning the attacks on East Gouta with chemical weapons.

The magnitude of the disaster was huge and the number of the victims and injuries was also so big. We consumed our stock in Jobar of Atropine and Hydrocortisone. I took out alone about 25 thousand units of Atropine from Jobar warehouse and nearly 7000 units of Hydrocortisone and about 35 thousand needles with various sizes. And, they have been distributed over the entire medical points in Jobar and Ain Tarma. The medical staff has worked with us actively and vigorously.

The number of the injuries and the victims and martyrs from children and civilians was very very big. The number of children who came to us is very big. The number of children who arrived to me alone was approximately 50. They were martyrs, they did not have any signs of being alive. I moved to Ain Tarma medical point and I provided them with some Atropine. I was also briefed on the work; everybody was working very hard. Some people had to retreat to other points, but they should not have moved; they must work in the frontlines. The negative thing that happened was dealing randomly with the matter and the poor education of citizens. The gas loses its effect after half an hour, but unfortunately citizens hid in basements although the gas is heavy and it comes down to basements. This increased the damages and the number of injuries. With the descending of the citizens to the basements, the number of injuries and martyrs increased. And, the increase in the number of injuries resulted in increasing the workload on us. Thus, we had to raise the maximum readiness with our total disability. We consumed approximately 200 oxygen cylinder in Jobar and Ain Tarma medical points alone.

We've got martyrs from our medical staff, may Allah accept them. Our friends also passed away, may Allah accept them. There was ignorance on

- There was ignorance on the part of citizens. In such cases, they must go to the upper floors. Some people also took the initiative to set fires resulting in the increased difficulty in breathing.

the part of citizens. In such cases, they must go to the upper floors. Some people also took the initiative to set fires resulting in the increased difficulty in breathing. This had led to more side effects; there was an overlapping of gases and inhalation of burned tire smoke and raging fire gases due to the ignorance of some people in burning tires. This thing should not have occurred. Now, we must work on a complete awareness program in the East Gouta regarding this matter. It should be addressed to citizens not to militants. In the case of chemical gases, they must go to open spaces and to the upper floors. I mean we must protect ourselves from mortar shelling, but we must sit in places which are exposed to air and where there is an air flow to get oxygen and reduce injuries; thus, decreasing the burden of injuries upon us. I can no longer talk! You can videotape the scene and the martyrs in front of you.

In the name of Allah most Gracious, most Merciful In early morning hours, what happened in the frontline of Jobar was that Ain Tarma was being bombed with chemical weapons. We were aware of the situation at an early time. Thank God, we raised the readiness and the perfection of work. Praise be to Allah,, all the adjacent medical points responded to us, starting from Zamalka medical point, Ain Tarma medical point, Jobar medical point and all the remote medical points. Even Deir Al- Asafeer and Douma medical points have participated in the work and the medical evacuation, may Allah reward them will all the best.

Bad situation: high scores of victims mainly children and women, in their houses. The symptoms (to become blue and to foam). We were not prepared. All my team of 26 were injured. We had a lack of medicine and a lack of oxygen. There were so many victims that we had to put them in the street. Water was the only treatment. Even atropine we had a big lack of it. All the victims were sleeping in their homes and we had to break their doors to put them out, the children, the elders and the womenOnly in my hospital: 250 martyrs. 90 women, 50 children and until today I have taken out (dead) families from their homes, the neighbours were telling me that bad smell is coming out from their houses. This "nurse" is saying in the end of the video that she is a djihadist who can fire mortars and use weapons. She gives the report of the Hospital Al Hajjeh in Ain Tarma during the alleged chemical attack.

The Chief of a field hospital of Al Ghouta is saying on Al Jazirah:



This medical person is affirming: "the women came...they came... from the bedrooms, they rescued them and some of them they could not rescue them some of them went up to the roofs on the basis that the chemical gas has more effects on the first and second floor, so they were injured with the chemical gas...the rescuer were also injured with the chemical gas. See his allegations here at 8'20"

It is important to note that, following the declarations of the medical team Spokespersons:

- The victims were rescued in situ, at home, where they were sleeping. Thus the locations of the victims were familiar to the rescuers so that they went immediately to help them. But then, why so few victims were identified?
- There is a contradiction in the stories. One says that the victims went to the basements and, thus, suffocated, because of the poisonous gas is heavier than air and would spread in the lower spheres. Another says that the victims went up to the roof and there it was safe for them.
- One says that he distributed huge amounts of medicines. The other says that people died due to the lack of medicines.
- Nobody gives any explanations about the high rate of the children among the victims and why
 they were brought alone to the medical points without their parents.

THE RESCUERS AND THE MEAN OF TRANSPORTING THE VICTIMS

Mohammad Al Saïd, member of the Revolutionnary Commandement of East Ghouta affirms that: People were sleeping in peace Then he contradicts himself saying "the children, the women, came to us with their pyjamas. All the children were sleeping in peace and the ambulances are still coming to here with the victims.

These affirmations are not patent in the footages. It is very strange that throughout all the ongoing rescue actions captured in the videos, the sound of an ambulance is heard only two times and only twice do we see an ambulance in action :to bring one sole child to a medical point and to transport the corpses for the burrial. We see two private cars carrying each time ONE child. How to explain the transportation of thousands of victims to the different medical points, especially that some victims were transported to farther places? There is complete mismatching between the alleged number of victims and the almost inexistent outdoor movement.

THE INJURED PERSONS

There is a lot to say about the injured persons. While ten to twenty people could surround one dead child, you will find persons that are allegedly dying without any help. But only forensic and specialized doctors can handle this subject.

The footages show a blurry reality of medical cares in the field hospitals and in the medical points of East Ghouta. Was it necessary to put everybody everywhere without order? Who is receiving the victims? What are the logical steps of a treatment? It is like an hecatombe that the careless way to administrate the medical cares and treatment makes more dubbious. How is it that in all the videos that are recorded in many different places we see the same arrangements? Many questions that only a very long and detailed investigation will answer.

The nominated Videos N°1 and N°6 are linked together. Both have a scenario that turns around a little boy with a red shirt who is suffering. N°6, produced by Jobar Local Coordination Committee, was uploaded 3 minutes and the half after N°1 which is a production of Hamouria Local Coordination Committee.

N°6 is previous in the chronology of the action: the clothes of the little boy are still dry. He is like in agony, shaking on a ceramic tiles floor. He seems alone.

In the video N°1, the same boy is all wet with a rose towel on his shoulder. A woman dressed in black with an orange scarf gives him pats on the back. Then she reclines him on the arm opened of a man laying on his right.

Let us note that the floor is not tiled with ceramic. It is another station for the little boy who, in the video N°6 was agonizing on white ceramic floor.

A very important detail that we have to note is that between the man and the little boy, on the floor, there is the presence of a cylinder. A man comes, always in the video N°1, and takes

the cylinder.

The title of the video on YouTube says: *More than one hundred martyrs that were rescued namely to Kafarbatna, due to the chemical attacks the 21/8.*

This nominated video raises serious problems concerning the manipulation of bodies of innocent people, especially children, alive or dead. This manipulation is a grave infringment of the laws of honest information but, in the case that death were provoked intentionally it falls under the procedure of criminal cases.

We have recognized the same room in a documentary of Al Jazeera. The shooting of the room in in this documentary is about an early arrangement of the mortuary groups. We see heredown the same room with only six children and one male. Strangely thaey are in the same position they will have when the room will be full. It means that it is not a spontaneous action of the "victims" that the footage transmit to us but rather a scenographic arrangement which could be acceptable if the scene setting was not with dead corpses. If those people have really fallen during the chemical attacks why all those manipulations with their bodies? Where did the producers and the rescuers find the time to cure, treat, heal, accompany and dispose bodies for a specific scenario?

- 2. In the nominated video N°11 the empty spaces seen in Al Jazera documentary are "filled" with 15 other bodies without moving the previous 7 we talked about.

The previous bodies are surrounded with yellow: 6 children and one adult male What we see is an evident unfair scenographic arrangement.

The first question here: how was it possible to add new bodies without moving those who where there first. Why was it done like this? Are those children and adults alive or dead? If they are alive, why to put them like this so much one nearby the other so that it is difficult to reach each one? If, sadly, they are dead, what are doing the "nurses"? We see one sitting on the body of a male laid down. She has a needle and she is injecting something.

The nominated video N°11 was uploaded the 21st of August at 08:44:40.000Z Damascus time. How is it possible that 4 hours after the chemical attacks so many corpses are gathered and arranged in a theatrical manner? How is it possible that Al Jazirah dispose of an ongoing arrangement for a final shooting? ¹

We are horrified when we realize that many of the above laying children, let them be alive or dead, are yet disposed in another place in another room in another City.

We have done the following comparisons:

The video at the right has been produced by the Press Office of Al Marj Region. It shows inanimate children laying on the ground in disorder. At least 9 of those children have been transported from Kafarbatna out of any medical or humanitarian explanation. It seems that the trafic of the bodies is to obtain, every time the best compilation to evoke to the international Community in the most expressive way the tragedy of the Chemical Attacks.

Another detail: the girl dressed in yellow, is layint in a scene that is said to be situated between Zamalka and Aïn Tarma. But we have found her figuring in another video, in Jobar!

Moreover, the two males that are seen in the nominated video N°11 in the first room with the chilren are also seen in this video of Al Marj: they have been transported to another place,



To conclude we can affirm: it is impossible to do all this arrangement in few hours. This means that the footages were realized BEFORE the event. This will raise crucial questions.



And before closing the problems raised by nominated video N°11 we have to address the fact that the sister of the little girl dressed in purple from the nominated video N°13 has been transported to figure with those children called the martyrs of Kafarbatna.



The two sisters are found in the nominated video 13 and in another one, both located in Erbin. But here is that the corpse of one is found in Kafarbatna!

CONCLUSION: How is it possible to carry corpses from one place to another when hundreds of victims were allegedly in need of care and of human resources with very little margin of time? Who are those children? Why are they used as a media tools without fearing to desecrate them? Where are their parents? What hides behind the video n°11 is scary.

We need to find out who are those children, where are their parents? Are they alive or dead and the real reasons of their death?

We have three major problems to resolve that prevents us to believe in the Bona Fide of the producer of this video and the videox that are related to it.

FIRST PROBLEM

We have seen that the girl in the video N° 13 was inanimate and her father is shouting with emotion that she has been killed with chemicals. BUT in another video upload by the same source (ERBIN CITY) 10 minutes later, the same girl is still ALIVE and being treated only with light health care. Her alleged father is NOT in the room and the rescuer who is taking care of her is saying: "I rely on God He is the best Provider: these are cases of fainting due to the inhalation of poisonous gas". She does not seem in a critical phase.

In the light of the second video, the nominated video N°13 raises different questions of timing, editing and uploading as well as those, more crucial, concerning the identity of the girls and the causes of their death.

SECOND PROBLEM

Here is the man who is carrying the girl in purple, saying that she calls him "Father", meaning that he is her father.

Here he seems to find her daughters again, they are laying with the "crowd" of children, on the right of the little girl in purple is another girl in pink.



The "father" enters in the minutes 15:48 saying:"Let the one who speaks about chemical stop lying to us." And he curses the Arab League, the United Nations etc... on the head of the girl with the purple shirt.

Questions: How did this father accepts that his daughters are to be buried within a mass ceremony. Where is the mother of the girls? Where is the family? How is this man alive while his daughters happened perished.

Now his two daughters are alone with the man that was with them in the nominated Video 13, uploaded one hour and half before. Six little corpses have been removed or added.....



Our question: two little girls, alive or dead, have been transported in less than 3 hours from their house to the medical point than to a room where there have been two reorganization of corpses, all this accompanied with a propaganda from the "father"? How can it be while 1466 people are dying and in need for urgent care?

THIRD PROBLEM

In the second video related to the little girl in purple we see a young boy lying on the patient cart on her right. The video source is Erbin City. The horodation is 21st of August at 01:00:54.000Z UTC time or 04:00:54.000Z Damascus time.

Conclusion

It seems there is a featuring that does not match with the dramatic intensity of the event. It has all the appearances of a heavy media manipulation, unless there is also something worst concerning the medical condition of the injured people, especially the children, and the reason why they die alone and why their parents are not with them.

ABOUT THE VICTIMS

THE REPORT OF THE UNIFIED MEDICAL OFFICE OF EAST GHOUTA



In the name of God the Merciful, About two in the morning, on Wednesday 21, 8, Eastern Gouta, in Zamalka Ain Tarma region, suffered indiscriminate shelling by Assad's forces. Mass suffocation and death cases started arriving to all medical points and field hospitals in East Gouta . All the medical staff, paramedics and activists were called to deal with casualties from Zamalka and Ain Tarma.

Injury evaluation was very confusing because of the sheer numbers. More than 30 % of the injuries were severe. Hence, most of the patients were transferred to other medical points and field hospitals.

Clinical panel of patients was very broad and included the following signs and symptoms:

- Respiratory difficulties of all levels.
- Heavy foam mucous secretions from the mouth and nose
- Generalized non-descriptive convulsions
- Agitation
- Pallor
- Heavy sweating
- Vomiting
- Narrowing of pupils
- Slow pulse
- Inflammation, especially in the upper part of the body
 These symptoms indicate case of poisoning with organic phosphorus comppounds.

Statistics in the medical points:

- 10,000 injured during the first six hours.
- More than 3,000 serious conditions.
- 1466 Martyrs
- We note that 67% of the casualties were women and children

We reaffirm that these statistics were inside the medical points. And until now, a lot of patients still come back to us due to recycling toxic material in the patient's body, as a sickly physiological mechanism.

Medical staff got poisoned by toxic substance through contact with infected patients in the absence of preventive solutions. Some of them died and others are now under treatment.

Consequently, the United Revolu-

tionary Medical Office announces Eastern Gouta as a disaster area, and called on the international community to assume its responsibilities and stop inaction about the tragedy of the Syrian people, and emphasize the following: First: The entry of the Observers Commission immediately to Ghouta to document what happened before the demise of the toxic substance due to its short half-life.

Second: We call on all organiza-

tions and medical relief agencies to act immediately, and freely to enter Ghouta to cover the deficit of medicine, medical consumables, equipment and relief services.

Third: We call on all free international human rights organizations in the world, to do their humanitarian job, and be responsible towards the tragedy of the afflicted Syrian people. Peace be upon you and God's mercy and blessings.

ABOUT THE VICTIMS

WHO ARE THEY, SPECIALLY THE CHILDREN?

CONCLUSION: Those affirmations find us very skeptical: In the context of a dense urban neighborhood, where people are "sleeping": where should the rescuers choose to go? The gas is invisible and odorless. Nobody knows where it is spreading. We know that the sarin gas is extremely volatile. The real danger was for those who would go out in the midst of the gas. So how could the rescuers move immediately without any adequate protection material and how could they afford to arrive to houses with injured people, to manipulate them and to rescue them with only handkerchiefs and tissue masks? Al Saïd, the member of the Revolutionary Commandment Council of Rural Damascus, supervising the making of the documentary of the chemical attacks in Zamalka:

He affirms,: "All the victims here are women. Of course all the victims are unidentified, they have a

number. Most of the bodies are women and children, 865 martyrs registered by names in the provinces of in East Gouta. The Syrian regime bombed areas in East Gouta, 3 kilometers away from the human rights committee sent by the United Nations to detect chemicals in Syria. No one reacted. They all denied that the Syrian regime used the chemical weapons. These bodies that we see all of East Gouta with dozens of cities in East Gouta.

The reporter says in the depot house: "We see here the corpses of the victims. The foam, sign of the influence of chemical is coming from their mouth. We see the children, like flowers...those children are victims of the criminality of the Syrian regime. We see numbers on their fronts. They are numbered so that if their parents they come they will be able to recognize them. Maybe their parents are injured like them, maybe they have been killed, maybe they are searching for them, they do not know anything about them. It is a dramatic scene. Children aged some years....Their only guilt is to be sons of Ghouta".

And until today on the Zamalka Facebook we see tens of faces that have no name: Unidentified.







The majority of those victims are unidentified. It is written on their shrouds and the facebook pages of the opposition in East Ghouta are full of pictures that are presented to be able to identify the victims. How come that in a besieged neighborhood where everybody is united by the same fate there are so many unknown?

WHAT ABOUT THE DIFFUSION OF THE DEATH TOLL?

Very quickly the Local Coordination Committees diffused the death toll
A number of victims was posted at 03:39, 39 minutes after the beginning of the presumed chemical strikes:



THE LAST STEPS OF THE VICTIMS

It seems that the victims were gathered in four dead depots: Kafarbatna, Erbin, Zamalka and Jobar. The "burial" seems to be in Douma where the victims are transported to a tent.

We see one small burrial group in Jobar.

THE BURIAL

After those preliminaries, begins the burial. BUT no evidences of more than EIGHT corpses buried. Among them three are not wrapped in white ???



It is very surprising that only 8 "victims" are burried, among them three without a shroud. Funerals, mourning and condolences have been almost inexistent.

THE CRUCIAL QUESTION

Eight corpses are seen burried. Remain 1458 corpses? Where are they? Where are the children? and the women?

Moreover: There have been no public burial, neither the announcement by the Muezzin as usual. Nobody heard of obituary notices neither a mourning tent was hold. The parenthood of those regions did not express the loss of a dear one. In Orient everybody is related to everybody and 1466 deaths are like a social hurricane. This is a real mystery that the lack of graphic evidence of the burial makes enigmatic. The neighborhood as seen in the map in the first page are not far than 3kms from the central Damascus. There is a continuous crossing from the civilian population from the so called "liberated areas" to the areas under the government control. The silence and, even, the social inconsistency of the reality of the "martyrdom" of the victims is a tricky problem. We think that there must be a "recognition" of the collective pits to be able to have an idea of the whole situation.

THE ABDUCTED CHILDREN AND ADOLESCENT FROM LATTAKIAH

The videos heredown concern the facts of the abduction of tens of Alawites civilians jut prior to the Chemical Attacks. We refer also the list of the victims of the invasion of 11 Alawite villages in Lattakiah the 4th of August 2013, were 150 women and children were abducted by Jobhat Al Nosra. We launch an appeal to the International Community and to Interpol for a warrant of Research and Investigation especially concerning the fate of the children and adolescents.

We have seen in the study of only 3 nominated videos how big have been the manipulation. Everything points out to a FORGED STORY and a FALSE FLAG concerning the alleged Chemical Attacks. We need to know more about the fate of those civilians.

CONCLUSION

Concerning the alleged Chemical Attack on East Ghouta, the International Support Team for Mussalaha (Reconciliation) in Syria has studied some of the 13 videos nominated by the US Intelligence Community to exhibit pieces of evidence to incriminate the Syrian State.

We have found that three nominated videos present evidence of artificial scenic treatment using the corpses of dead children.

Studying the whole videotaped documentations available on line, from the point of view of the structure of the Syrian society, we find that the civilian population in East Ghouta as presented in those videos is inconsistent with the composition of a real Syrian civilian society. There is a flagrant lack of real Syrian families in East Ghouta, as presented by the videos. So with the terrible sense of the existence of a horrible crime, we ask: Who are the children that are exposed in those videos?

From where do they come? Where are their parents? How did they get killed? Where are their corpses buried?

We think that with the evidences of media manipulation that are shown in the this Study and other studies, there is a moral obligation to launch an International investigation and arrest Warrant under the yellow and black notice to find and identify the Syrian children bodies used in a criminal way in the so called Chemical Attacks of East Ghouta.

On the other hand, we are in close contact with the survivors of the horrendous massacres perpetrated the 4th of August 2013 by Jobhat El Nosra and al-



lies in eleven villages from Lattakiah mountains. As Reconciliation Committee we are trying to liberate more than 150 women and children, abducted under the pretext to exchange them with detainees. We have been contacted by the families of some abducted women and children. They recognize their relatives in the videos published online that show the alleged victims of the Chemical Attack in East Ghouta.

Some families have filed a complaint to the Syrian authorities in Syria. They need to be heard on an International level. We need to help raise International Awareness toward the humanitarian case of the criminal use of children in the East Ghouta Chemical Attack. **Would you join us?**

There is an urgent need for an independent and unbiased International Commission to see where are the children and what is their identity. Should they have died, their corpses need to be found to proceed to a DNA investigation. Only then total light will be shed on this historical case of mass manipulation.
